HOW TO MAKE AN APPLICATION

To make an application to invest in The Mortgage Fund ARSN 227673 (Fund), you will need to:

- 1. Ensure you have carefully read the current Target Market Determination (TMD), and Product Disclosure Statement (PDS), including the current ASIC Benchmarks and Disclosure Principles Report (Benchmark Report) which can be found online at www.stacksfinance.com.au.
- 2. Determine whether you fit within the target market of the Fund and that the Fund is consistent with your objectives, financial situation and needs.
- 3. Select the relevant Application Form/s, which can be found online at www.stacksfinance.com.au.
- 4. Fully complete the relevant Application Form/s and attach your cheque (marked "not negotiable") made payable to: STACKS MANAGED INVESTMENTS LIMITED <insert your name>.
- 5. If you wish to deposit your investment funds by direct debit, please call our Member Services team on (02) 6591 3444 to obtain our bank details.
- 6. If you are a NEW INVESTOR in order for your application to be considered, carefully read the requirements listed on the second page of the relevant Application Form about the information you need to provide.
- 7. If you are an EXISTING INVESTOR please remember to tick the appropriate box on the first page of the relevant Application Form which asks whether any of the details you previously provided to Stacks Managed Investments Limited ABN 81 085 843 125 (Stacks Finance, SMI, Trustee, our, us) have changed. If your details have changed, please provide the amended details in the section for a new investor and provide the appropriate documentation with your application to support the change/s.
- 8. Ensure that the Application Form is signed by the applicant or appropriate person/s, for example:
 - If the applicant is an individual, that individual must sign.
 - If the investment is to be held jointly, all applicants must sign.
 - If the investment is held by a partnership, all partners must sign.
 - If the investment is held by a company, the following may sign: either
 - Two directors;
 - A director and a company secretary;
 - o If a sole director, that director; or

- An authorised representative;
- 9. Ensure that, if appropriate, a Withdrawal Authority is completed and provided with the relevant Application Form.

10.To lodge your Application Form/s, you can:

Please note that if you are signing under power of attorney, we require a certified copy of the registered power of attorney.

The Target Market Determination

Stacks Finance has a series of obligations under the law when promoting its funds to investors. One of those obligations requires us to take reasonable steps to ensure that the Fund, including its key attributes, is likely to be consistent with the likely objectives, financial situation and needs of consumers in its target market.

The Application Form

Types of Application Forms

Our Application Forms are tailored to particular customer types. This is to ensure our Application Forms are user friendly. It also enables us to collect from you specific information relevant to your customer type, in compliance with the AML/CTF Act and AML/CTF Rules.

If you are:

- an individual please complete Application Form 101.
- an individual who is a sole trader, please complete Application Form 102.
- an Australian company please complete Application Form 103.
- a trust please complete Application Form 104 and also, in respect of the trustee, Application Form 101 for individuals and/or Application Form 103 for Australian companies, whichever is relevant.
- a partnership please complete Application Form 105 and also, in respect of each partner, Application Form 101 for individuals or Application Form 103 for Australian companies, whichever is relevant.

- an association please complete Application Form 106 and, if the association is unincorporated, in respect of a member of the association making the application, Application Form 101 for individuals.
- a registered cooperative please complete Application Form 107.
- an Australian superannuation fund please complete Application Form 108 and also, in respect of the trustee, Application Form 101 for individuals and/or Application Form 103 for Australian companies, whichever is relevant.

Under the AML/CTF Act and AML/CTF Rules, we may contact you for additional information in order to approve and process your application to invest.

To assist you in completing our Application Forms, on page 4 we have provided an Application Form checklist.

Processing of Your Application

Wherever possible, Application Forms (and cheques) received by 12.00 noon (Eastern Standard Time) will be processed on that day. Cheques and Application Forms received after 12.00 noon (Eastern Standard Time) may be processed on the next business day.

After each investment is processed, a summary of your account details, including the dollar value of your investment, the number of units issued and the date on which you acquired them, will be sent to you. Certificates are not issued. Your details are entered on the Register of Members for the Fund, which is maintained by Stacks Finance.

Making additional investment Applications

You can add to your investment by making additional investments of any amount. You will need, however, to complete a separate Application Form for each additional investment.

Have your details changed?

If your details change, you can inform us by letter or phone, or you may inform us of these changes with your next Application Form. If the investment applicant has changed its name, an original certified copy of either the marriage certificate/deed poll or certificate of incorporation on change of name must be supplied with the Application Form.

Withdrawal Authority

The Withdrawal Authority, contained at the back of the Application Form, enables you to instruct us of the persons who have signing authority for your investment, for the purpose of making withdrawals. This will be particularly relevant if you are a company, partnership, or association. However, the Withdrawal Authority is also relevant if you have a joint investment and would like to allow one of the joint investors to solely make withdrawals.

You should carefully read the conditions on the Withdrawal Authority and specify the appropriate signing authority. If no election is made as to the number of signing authorities, we assume any one of the parties listed on the Withdrawal Authority has signing authority.
